THURSDAY	13 OCTOBER	<u>SYDNEY, BRISBANE, MELBOURNE / AUCKLAND</u> Depart Australia. MONDAY

17 OCTOBER

AUCKLAND / ROTORUA

Today you will be joined by your tour coach and driver for your 4 day exclusive coach charter.

En route there will be a visit to a Vineyard for a wine tasting tour which will include lunch.

Transfer to Rotorua where you will stay for the next two nights on a bed and breakfast basis.

Your tour coach is available in Rotorua to visit Te Puia, the Agrodome or enjoy the Skyline Gondola.

TUESDAY

18 OCTOBER

ROTORUA

Full day of activities in Rotorua.

This evening you will enjoy the Maori Hangi and Cultural Performance.

WEDNESDAY

19 OCTOBER

ROTORUA / TAUPO

Transfer to Taupo where you will visit Huka Falls and have the opportunity to take the Shotover Jetboat ride.

The Huka Falls are the largest falls on the Waikato River, near Taupo on New Zealand's North Island. They are the most visited natural attraction in New Zealand

Check into your accommodation for a one night stay on a bed and breakfast basis.

Taupo is a vibrant community with a buzzing café and restaurant scene, varied nightlife and some great pubs and lounge bars. The outdoor lifestyle is second to none here with easy access to the bush, lake and mountains.

Lake Taupo covers an area stretching from Orakei Korako in the north, to Tongariro National Park in the south. You'll find snow capped mountains, an enormous fresh water lake (the largest fresh water lake in Australasia, created by the world's largest volcanic eruption of the past 5000 years), pristine native bush, steaming thermal areas and one of the world's only Dual World Heritage Parks.

THURSDAY

This morning after breakfast transfer to Waitomo Glow Worm Caves where you will have a 45 minute guided tour.

After lunch continue to Auckland.

On arrival check into your hotel for a four night stay on a bed and continental breakfast basis.

RESPONSIBILITY

Gullivers Sport Travel Pty Ltd (which expression shall for the purpose of these conditions include and parents subsidiary affiliate or associated company and herein after shall be called "the Company") acts only as agents for the hotels, airlines, bus or car companies, railroads, steamship lines, or owners or contractors providing accommodation, transportation or other services, and all coupons, exchange orders, receipts, contacts and tickets issued by the Company are issued subject to any and all tariffs, terms and conditions under which any accommodation, transportation or any other services whatsoever are provided by such hotels, airlines, bus or car companies, railroads, steamship lines or owners or contractors. The Company shall not be liable or responsible for death of or injury to any person or loss of or damage to any property or otherwise (including baggage) whether due to its servants agents or employees negligence or otherwise arising out of or in connection with any accommodation transportation or other services or resulting directly or indirectly from acts of God, dangers incident to the sea, hijack, fire, breakdown in machinery or equipment, acts of governments or other authorities, de jure or de facto, wars, whether declared or not, hostilities, civil disturbances, strikes, riots, thefts, pilferage, epidemics, quarantines, medical or customs regulations delays or cancellations of or changes in itinerary or schedules or overbookings or defaults, or from any causes beyond the Company's control or through the acts of default of the hotels, airlines, bus or car companies, railroads, steamship lines or owners or contractors providing accommodation, transportation or other services or for any loss or damage resulting from improper or insufficient passports, visas or other documents and that neither the Company nor its servants agents or employees shall be or become liable or responsible for any additional expenses or liability sustained or incurred by the tour members as a result of any of the foregoing causes. All prices quoted are subject to change without notice having regards to unforeseen circumstances, foreign exchange fluctuations and variations in airline operating costs including but not limited to say an escalation of fuel prices. Unused services cannot be refunded or exchanged. The Company reserves the right to cancel the tour and/or modify the itineraries in any way it thinks desirable and further reserves the right to decline to accept any person or any tour and may substitute hotels where necessary. The issuance and acceptance or receipts, tickets, vouchers, coupons or travel orders shall be deemed consent to the above.

Tour Prices: The costs for all tours are based on current airline schedules, airfares and a minimum of 40 passengers traveling together on each tour coach. Land costs are based on an exchange rate of 1.30 (selling rate) against the New Zealand Dollar. Tour costs shown are subject to alteration (up or down) due to exchange rate fluctuations and increases in land and air costs which arise prior to receipt of final payment. Costs will also depend on availability of hotels quoted on. Tour prices are sold as a complete package. Alterations and deviations during the tour itinerary will not be accepted.

Prices for Travel Arrangements: All travel arrangements booked for the passenger/s have been based on costs at the time of booking and are subject to change in accordance with advice from the service suppliers regarding changes to airfares, fluctuation of exchange rates, increases levied by the service suppliers or variations in the itinerary caused by cancellation or curtailment of services or rescheduling. The passenger agrees to pay any such additional charges prior to departure and prior to ticketing time limits and travel departure date.

Tax invoices will be issued prior to the relevant due dates – late payment may result in the cancellation of your reservation and will be subject to cancellation fees. Deposit and payment conditions for extended travel arrangements will be advised when bookings are requested.

Cancellation penalties :

All deposits and further payments are non refundable. In no circumstances will any monies paid under this Agreement be refunded by the company to the Passenger. Passengers will not be entitled to a refund for any unused services after commencement date of their trip. It is therefore strongly recommended that passengers take out suitable travel insurance including a clause covering cancellation penalties.

Amendment Fee : Any person wishing to amend from the group tour arrangements before or after the tour package must notify Gullivers Sport Travel in writing and will be charged a standard \$100.00 amendment fee per person plus any additional charges involved with the amendment (increase in airfare, additional transfers, accommodation etc). Please note that your deviation may be subject to airline / supplier season changes and may incur additional costs, surcharges & taxes. All tours are sold on the basis that no tour can be altered for an individual or group between the tour start and finish date.

Documentation: All passengers travelling on an Australian passport must have a passport valid until their return date to Australia. Passengers traveling on a passport other than an Australian passport must advise Gullivers Sport Travel to ensure you meet visa requirements overseas and on your return to Australia. Visa requirements are the passengers own responsibility. Please ensure all names provided to us are as per the passengers passports.

Baggage: Free baggage allowance one piece weighing maximum 20 kg plus 1 cabin bag (piece) of 115cm with a maximum weight of 5kg per person (economy class). Luggage in excess of these limits will be charged at the appropriate excess baggage rates by the airline. Baggage is the responsibility of the passenger at all times (Travel Insurance is strongly recommended).

Travel Insurance Protection: Travel insurance is strongly advised for all tour members. Brochures detailing coverage are available from Gullivers Sport Travel's preferred insurer and will be forwarded to you on request.

Accommodation : If you are wanting to share with another tour member we will endeavour to meet your request. However in the event that this it is not possible then the single room supplement must be paid. Please note: hotels & locations mentioned in itineraries are subject to change due to the high demand of accommodation over Rugby World Cup 2011.

Airport Taxes (Departure, Arrival, Security & Government taxes etc) : Are not included in the tour cost as they are continually changing ie. due to exchange rate fluctuations, adding & deleting of taxes etc. Taxes will be advised and payable at the time of final payment.
